Government of Assam (GoA), through the Government of India has received a line of credit for US\$200 million from the World Bank (W.B.) for implementation of the Assam Agribusiness & Rural Transformation Project (APART). The proposed Project Development Objective is to -increase value-added and improve resilience in the production and processing of selected agriculture commodities, focusing on small farmers and agro-entrepreneurs in targeted districts.

The APART Project in Assam state is being implemented by ARIAS Society, which is an autonomous society registered under the Societies Registration Act and the project is being implemented by various line department/agencies of Govt. of Assam.

The West Assam Milk Producers Cooperative Union Limited (WAMUL) is an implementing agency for the Dairy Formal Milk sector under the APART project and intends to utilize a part of the credit towards procuring goods for implementing activities under the Dairy Formal Milk sector.

WAMUL invites Quotations in sealed envelopes from eligible bidders for supply, installation, testing and commissioning of WALK – IN COOLER as per the specification, scope of work & other terms and conditions as detailed below:

The price bid should be as per format given in Annexure -2

### Terms and Conditions for Request for Quotation (RFQ)

#### **1. Eligibility criteria of the bidder**

1.1. The Bidder Should be Manufacturers/OEM/Dealers authorized by Manufacturers of Puf panel/refrigerant equipment. (Relevant documents required)

1.2. The bidder should have completed at least 5 contracts for same/similar items each of value more than Rs 20L (TWENTY LAKH) in last 3 years or successfully complete at least 25 nos of Walk In cooler in each of the last 3 years. (Relevant documents required: Client list, relevant PO copies).

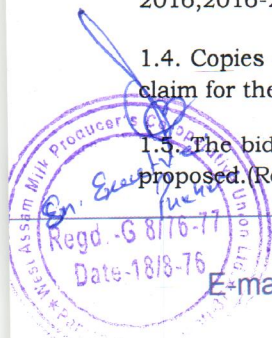
1.3. The bidder's Financial Turnover in each of the last three financial years ending 31<sup>st</sup> March i.e. (FY 2015-2016,2016-2017,2017-2018) and should be more than Rs 10 Cr. (Relevant documents required)

1.4. Copies of Contract completion certificates and TDS certificates used by the clients to substantiate the claim for the value of contract executed.(Relevant documents required)

1.5. The bidder should have valid registration under various Acts that may be applicable for the contract proposed.(Relevant documents required)

1.6. The bidder should have own manufacturing unit of Puf panel/refrigerant equipment or should be specially authorized by such manufacturer which have ISO certification and turnover more than Rs 100 Cr.

1.7. The bidder should have own or authorized service center at Guwahati (Certificate of Authorization need to submit)

1.8 The bidder should have own technical & installation staff (proof of employment needs to be submitted)

## **2.Earnest Money Deposit (EMD):**

2.1. The interested bidders have to provide a bid security of amounting Rs 20,000/- which will be presented in the form of a demand draft drawn in favour of "The West Assam Milk Producers' Cooperative Union Limited, payable at Guwahati". Bid security will be returned to the bidders within 4 weeks from the date of finalization of the successful bidder. Bid submitted without the requisite EMD shall be summarily rejected. No interest shall be paid by WAMUL on EMD amount deposited by bidder.

## **3.Performance security:**

Within 30 days of the receipt of the notification of the Award of the Contract from the WAMUL the successful bidder shall furnish to the WAMUL a performance security for an amount of Rs 100000/- in the form of Bank Guarantee or a Bank Draft from any Nationalized Bank in favor of "The West Assam Milk Producers Cooperative Union Limited, Juripar, Panjabari, Guwahati-781037". The Performance Security furnished by the successful bidder will be retained by the office up to 45 days after completion of the work. The PBG held by the office till it is returned to the successful bidder will not earn any interest.

Failure of the successful bidder to furnish Performance Security within the period stipulated shall constitute sufficient ground for annulment of award and the Office may make the award to the next lowest evaluated bidder.

**4.Validity of the Quotation:** Quotation must be valid for 120 days. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.

**5.Delivery/Completion Time:** Delivery of the entire material should be completed as per the schedule mentioned there in to be strictly followed. In such case overall completion of contract shall be 120 days.

## **6.Price Bid**

6.1. The Prices shall be quoted in Indian Rupees only

6.2. Freight: To be arranged by the supplier.

6.3. Packing, Forwarding, Freight, Insurance and other incidental charges shall be shown separately.

6.4. Each bidder shall submit only one quotation. Bidder shall not contact other Bidders in matters relating to this Quotation

6.5. The contract shall be for the full quantity as described above. The quantity of the items may be staggered depending upon the actual requirement.

**7. Terms of Payment:** Payment for item delivery will be made as per consignment delivered in accordance with the delivery schedule. 30% payment would be made in advance against Bank Guarantee (BG), the BG format will be provided by WAMUL to the successful bidder & balance amount to be paid after successful receipt of the material, Successful commissioning and Installation.

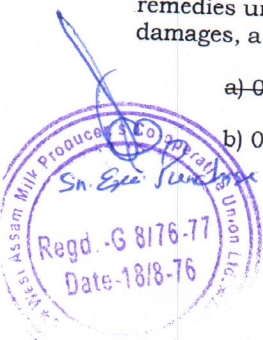
**8. Warranty:** The warranty should be valid for 18 months from the date of PO or 12 months from date of receipt of the material/manufacturer warrenty.

**9. Liquidated Damages:** If the bidder fails to deliver any or all the goods or perform the services within the time period(s) specified in the purchase order/contract, the WAMUL shall, without prejudice to its other remedies under the purchase order/contract, deduct from the purchase order/contract price, as liquidated damages, a sum equivalent to the following clauses which is applicable as per Order.

a) 0.5% of the full contract value for each completed week of delay

**OR**

b) 0.5% of the value of delayed items/services only, for each completed week of delay.



The total amount so deducted shall not exceed 10% of the purchase order/contract value. Once the maximum is reached, the WAMUL may consider cancellation/termination of purchase order/contract, and forfeiture of performance/ deposit bond

**10.Evaluation of Quotations and Award of Contract:**

10.1. The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e which Are properly signed; and Conform to the terms and conditions, and specifications

10.2. The quotation would be evaluated for complete set of item under this RFQ.

10.3. GST, Packing, Forwarding, Freight & Insurance charges in connection with sale of goods shall be taken into account in evaluation.

10.4. The Purchaser will award the contract to the bidder who has complied to our Technical Specification and who has offered the lowest evaluated quotation price.

10.5. No price negotiation will be done with any bidder. The purchase order will be issued to the lowest responsive bidder

10.6. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

10.7. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall incorporate in the supply order.

**11.Cancellation of Contract:** WAMUL shall be free to cancel the order either in full or in part, in the case of non-delivery of material/non-completion of installation within the stipulated delivery period.

**12.Rejection:** WAMUL reserves the right to reject the goods either in part or full if at the time of delivery, it is noticed that the goods supplied do not conform to the specifications/description given in the purchase order

**13.Bidder should submit:** Self attested copy of PAN, Self-attested copy of GST, Self-attested copy of Trade License, Bank Account details on letterhead of the firm, contact details.


**14.**For any dispute/legal issues, the jurisdiction is at Guwahati Only

Quotation can be submitted in person on or before the due date and time specified above. Such quotation should be dropped in the tender box only kept at the Office of the "West Assam Milk Producers Cooperative Union Limited, Juripar, Panjabari-Guwahati-781037"

Alternatively, the bidder can submit the quotation by registered post so as to reach the above address on or before the due date and time specified above. Quotation received after due date and time will not be considered and WAMUL shall not be liable or responsible for any postal delays.

The completed RFQ document duly signed on all the scanned signed pages by WAMUL should be submitted by the bidder along with the offer letter.

#### Scope of Work/Supply:

1. The bidder will provide all labour and manpower during the unloading of material, installation of Walk - In cooler and commissioning.
2. The bidder will supply the entire material relating to Walk - In cooler upto the delivery point as mention in delivery schedule
3. The bidder will deliver the material at good condition.
4. Walk In cooler with PUF panels as per specification is suitable for outdoor installation. However, roof/Shed shall be provided by WAMUL.
5. All control & display will be provided by bidder.
6. All power and control cable with try/ conduit are to be provided by the bidder with installation.
7. Air curtain & PVC certain (flaps) to be provided at the entry door.
