- c) The bidder should be registered on Assam Pollution Control Board for Recycling of Processing of Plastic Waste/Hazardous Waste Copy of such permission and or certificate must have to be enclosed along with the Bid.
- d) The bidder should have a registered office in Guwahati, Assam
- e) The bidder must have permanent account number (PAN) issued by Income Tax Department.
- f) The bidder must have a GST Registration Certificate.

- **4.** The contract will be empaneled as Annual rate contract basis. There will be no changes in rate during the contract obligation period of 1 year from the date of commencement of order.
- **5. EMD:** The bid security (EMD) of **Rs. 50,000.00/-** should be paid by Demand Draft in favor of "West Assam Milk Producers Cooperative Union Ltd" payable at Guwahati-781037. The EMD can be forfeited by the seller (WAMUL), if the service is not rendered by the bidder.

**Note**: The EMD furnished by the bidder will be retained by the office up to the entire contract period and returned within 60 days of expiry of the contract. The EMD held by the office till it is returned to the successful bidder will not earn any interest.

**6. Validity of the Quotation**: Quotation must be valid for 120 days from the due date of Submission The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.

#### 7. Price Bid

- 6.1. The rate should be quoted in the format enclosed as **Annexure-I**. The rate to be quoted in Indian Rupees only.
- 6.2. The quoted rate will be remaining same for one year from the date Annual Rate Contract (ARC).
- 6.3. The GST, if applicable, shall be quoted separately. GST, charges in connection with the services shall be taken into account in evaluation.
- 6.4. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be adjusted/ amended on any account except in case of statutory changes as per Government notifications from time to time.
- 6.5. The bidder should submit only one quotation. The bidder shall abstain from meeting/contacting other bidders in matters related to this bid.
- 8. Buyer needs lift the material from West Assam Milk Producers' Co-op Union Limited, R. K. Jyoti Prasad Agarwala Road, Juripar Panjabari, Guwahati 781037, Assam.
- 9. On receipt of Seller confirmation, the contract notes would be issued to the buyer and seller.
- 10. After issuance of contract notes to respective buyers, buyers need to provide required documents for vendor registration to West Assam Milk Producers' Cooperative Union as per their rules and regulations.
- 11. The tentative frequency of scrap material lifting will be 4times in a month with 7alternate days. However, prior intimation will be given by competent authority of WAMUL for lifting scrap as and when required.
- 12. Transportation & labour cost will be borne by the bidder.
- 13. Loading/unloading or any other incidentals will be borne by the bidder
- 14. 100% advance payment to be made by buyer to West Assam Milk Producers' Cooperative Union Ltd. before lifting the materials.
- 15. The buyer shall be required to lift materials as per lifting schedule mentioned in the Sales Order. The order is liable to be cancelled at the option of the Union if not executed in time.
- **16.** The Union reserves the right to grant / refuse the extension of lifting period to the buyer.
- 17. In case the successful bidder fails to lift the stocks or fails to pay within the stipulated contract period the seller will be free to rescind the contract and dispose off the stock. In this case, the margin deposited by the buyer will stand forfeited and passed on to the seller affer recovering the applicable transaction fees.
- 18. The unit of trading shall be in Rs. per Nos/Kg/Pcs.
- 19. West Assam Milk Producers' Cooperative Union Ltd. do not bind itself to accept the highest 76-7

or any and reserves to itself the right to accept any Enquiries or reject any or all Enquiries in whole or in part, without assigning any reasons for doing so.

- **20.** All taxes, duties, levies and other statutory charges and the surcharges thereon, if any under any local laws. Provincial or central statue in force for the time being or in force hereafter having its impact on the transaction will be purchaser's account and shall be deposited by him along with the cost of material i.e. GST will have to be paid by purchaser over and above the purchase acceptance cost of scrap.
- 21. The rate of duties and taxes ruling on the date of actual removal of material shall be applicable.
- **22.** The goods are offered purely on 'AS IS WHERE IS' basis. Pick and choose method of collection is strictly prohibited.
- 23. All statutory requirement and labour enactments should be strictly followed in respect of persons employed by the Purchaser(s).
- 24. The purchaser's representatives, workers, Lorry drivers and others will have to strictly observe the working hours and regulations regarding the discipline and security while they are inside the premises of West Assam Milk Producers' Cooperative Union Ltd. Any violation of the regulation regarding discipline and security will lead to forfeiture in Security Money and termination of the contract by West Assam Milk Producers' Cooperative Union Ltd.
- 25. The Purchaser(s) must not indulge in any corrupt or unlawful practice while executing the contract. If any such case is reported and established, The West Assam Milk Producers' Cooperative Union Ltd. will have full rights to forfeit the Security Money and cancel the contract.
- **26.** The bidder should not have been blacklisted by any State/Central Government Department/PSU/ Agency in the past for breach of general or specific conditions of contract, fraudulent, unethical or corrupt business practices. In this regard an up to date affidavit on Non Judicial Stamp Paper from public notary/ legal competent authority is to be submitted.

Note: WAMUL has full right to reject the bid of any agency that has been rendering poor service or rendered poor service during past occasions at WAMUL or any other organization.

- 27. Liquidated Damages: If the bidder fails to deliver any or all the goods or perform the services within the time period(s) specified in the purchase order/contract, the WAMUL shall, without prejudice to its other remedies under the purchase order/contract, deduct from the purchase order/contract price, as liquidated damages, a sum equivalent to the following clauses which is applicable as per Order.
  - a) 0.5% of the full contract value for each completed week of delay

OR

b) 0.5% of the value of delayed items/services only, for each completed week of delay.

The total amount so deducted shall not exceed 10% of the purchase order/contract value. Once the maximum is reached, the WAMUL may consider cancellation/termination of purchase order/contract, and forfeiture of performance/ deposit bond.
